Sub: Decisions taken in the CHQ.'s e-Secretariat Meeting- reg Kindly refer to the above.

- 2. As you are aware that the e-Secretariat Meeting of the CHQ. took place on 12th January, 2021 through webex. The Secretariat Members deliberated on the agenda items, in depth, and took the following decisions:-
- a) To demand the extension of Time Barring date from 31st March, 2021 to at least 30th September, 2021, for various proceedings under the Act on account of the functional difficulties as highlighted by the Committee constituted for this purpose by the CHQ;
- b) To get clarity regarding the completion of the TB Penalties by the Officers posted in NeAC/ReAC or by JAO; Notification with regard to shifting of time barring penalties to faceless regime has already been issued today i.e. 13.01.2021.
- c) To demand for immediate regularisation DPCs for the RYs 2016-17, 2017-18 & 2018 batches, latest by 31st March, 2021. The CHQ & OBs of the Units would take all out efforts in clearing of the remaining 33 APAR deficiencies and forwarding of the requisite certificates by the PCCsIT to the HRD;
- d) To demand filling up of the 177 vacancies in the grade of ACIT, in additions to the vacancies for the RYs 2019 &2020, as suggested by the Committee constituted by the CHQ. in this regard;
- e) To demand ITO to ACIT promotions for RYs 2019 & 2020, simultaneously with the regularisation of the pending 3 RYs;
- f) To demand STS to 2014-15 & 2015-16 batches, immediately;
- g) To demand the conduct of the long pending DPC, immediately, for filling up the 21 posts of Pr.AO;
- h) To demand for re-sending the proposal to the competent authorities for bringing Pay Parity to Sr.PS & PS with CSSS cadre, on the basis of the recent Hon'ble HC, Delhi's decision in the case of officers posted in the similar cadre in AIIMS;

- i) To demand for NFSG for the left out officers of 2008 batch on account of misinterpretation of certain provisions of the RR;
- j) To demand regularisation DPCs for RYs 2009, 2010 & 2011 batches of the JCsIT, at the earliest;
- k) To demand long pending implementation of judicial pronouncements wrt notional pay fixations wef 01.01.1996 and revision of pay from 01.01 2006 in the grade of ITOs;
- I) To review the ongoing agitation in the light of the redressal of our demands and with consultation with our JCA partner;
- 3. I, on behalf of ITGOA (CHQ), assure all of you to take up all these issues at the highest level for early resolution. Soliciting your kind cooperation in this regard.
