Sub: Issuance of RSA Token to officials of the Income Tax Department - reg.

Kindly refer to the above.

2. The ITBA application has been designed to facilitate delegation of work to the associated Staff by the Officers. Inspectors/Staff can login into ITBA application using their own credentials and work on the task delegated by their controlling Officers. However, this functionality is not being utilised adequately.
3. In this regard, reference may kindly be made to the letter dated 17.09.2019 by the DGIT(Systems) (copy enclosed as Annexure -1) as per which staff members of the Assessing Officer should obtain RSA tokens so that they can work on the delegated works. Further, DGIT(Systems) has also provided enough RSA tokens to the respective CIT (Admn. & TPS) for distribution to Inspector and associated Staff. The local RCCs, which come under the administrative control of the CIT (Admn. & TPS), have been entrusted with the task of distributing RSA tokens and assigning respective roles in ITBA to staff.
4. It is noticed that the stock of RSA tokens lying unutilised with the various RCCs all over the country is in excess of 13000 (Annexure - 2). This shows that many Officers are not able to delegate work to their Staff.
5. In this context, it is requested that all staff posted with Assessing Officers are given RSA token immediately and their roles are properly tagged by the respective RCCs. This will not only enhance the productivity of field formations but will also ensure security best practices.

Dear Pr Chief Commissioner / Chief Commissioner/ Pr Director General/
Director General,

It has come to the notice of the Directorate of Systems that the Assessing officers continue to share their RSA token and ITBA password with their Inspectors and staff for working on ITBA/ITD, in complete disregard of the security policy. The following table conveys the extent of the problem:

User Category	Total Count	With RSA tokens	% allotment
Inspector	14178	1698	11.97
Staff	24695	2608	10.56

This has adversely affected the productivity of the field officers and also given rise to many vigilance issues. In line with the security policy, Directorate has provided for sufficient RSA tokens for distribution to Inspectors and staff. For convenience of the field formations, the local RCC's have been entrusted with the task of distributing RSA tokens and assignment of roles. Simultaneously, the ITBA application has been so designed as to facilitate delegation of work by the Assessing officer to staff. Inspectors/staff can log into ITBA using their own login credentials and work. Through

such functionality the need to share RSA token/password with staff /others has been precluded.

In this context, the following decisions have been taken:


- a) Each Assessing officer may be directed to ensure that Inspector/departmental staff members of his team obtain RSA tokens and have it tagged with the AO's role.
- b) AOs must delegate work to Inspector/staff using submit /delegate functionality available in all modules of ITBA.
- c) Local RCC officers may be directed to promptly process requests for allotting RSA tokens and tagging of roles with that of the AO.

This exercise may be completed in a time bound manner so as to enhance productivity and to ensure use of RSA token by the authorised user only.

Considering the seriousness of the matter, you are requested to ensure compliance of the above decisions by 30.10.2019.
