Sub: - T & P Orders in the cadre of DCIT/ ACIT - regarding

Kindly refer to the discussions held with your goodself in respect of the T&P orders in the cadre of ACIT/ DCIT. The Association has been regularly representing the grievances of its members and raising various issues including uniform implementation of T&P Policy, circulated by the administration, in a fair and reasonable manner.

During discussions with the various levels in the hierarchy of administration on this issue, it transpired that 55 Officers have been posted in Delhi charge after completion of training at NADT and to accommodate these Officers the administration was compelled to divert from the established T&P policy in the cadre for many years, re-circulated by the administration on 8th May, 2017. As a result of such diversion, all the officers (except 3) who were posted last year in corporate charges have been transferred out, in violation of the policy framed and circulated by administration.

The posting orders in Delhi charge in the cadre of ACIT/DCIT have been passed in total disregard to the established policy and to the **DO letter of the Member (P&V) dated 1.5.2017** vide which emphasis was laid on posting Officers of the level of DCIT to important charges such as Central, Investigation, Film Circle and Corporate charges. To the contrary, 15 DCsIT have been transferred out of the Corporate charges and 36 ACsIT have been posted to corporate charge out of

total 51 Officers posted in Corporate charges. Most of the Officers especially all the **DCsIT transferred out of corporate charges have not yet completed their tenure as per policy** circulated by administration in FY 2016-17 and 2017-18 both. It is bring on record that posting profiles of the Officers in the cadre of DCIT having served long periods in the Directorates, hard stations outside Delhi etc has also not been considered while ordering their transfers.

This issue has been raised in the meetings held with your goodself and the CIT (Admn. & TPS) even after the passing of the orders dated 24th May 2017, however the administration has opted not to take into cognizance the facts and views expressed by the recognized association while framing the revised orders on 9th June 2017. It is painful to write that the posting profile of all the Officers in the cadre of ACIT/ DCIT was also not provided to the recognized Association, inspite of repeated requests.

It is requested that your goodself being the Pr CCIT, Delhi and as member of the Local Placement Committee may kindly reconsider all the facts mentioned above and revisit recommendation / decision so as to implement the established T&P policy, re-circulated on 8.5.2017, in light of the DO letter dated 1st May 2017 of Member (P&V), CBDT, New Delhi.
