- 2. Transfer & Posting Order of ITOs made vide S. No. 50,309 & 413 of the T&P order No. 102/G.0/2020-21 dated 23.09.2020, hereby stands cancelled.
- 3. All ITOs transferred vide this order are directed to join their new place of posting by A/N of 13th October, 2020. They are also directed to complete the necessary actions related to merger/transfer of charge before relieving. Respective PCsIT/HoDs shall ensure that all statutory requirements under Income-tax Act, 1961 are completed by these officers before relieving.
- 4. All the above transferred Income Tax Officers and officers transferred vide order No. 64/G.O./2020-21 circulated vide F.No. P-328/T&P/ITOs/2020-21/1026 dated 28.07.2020 and Order No. 102/G.O./2020-21 circulated vide F.No. P-328/T&P/ITOs/2020-21/2851 dated 23.09.2020, shall be treated as deemed relieved w.e.f. 13.10.2020(A.N).
- 5. The Controlling Officers should ensure that the officer after being relieved submits his/her self appraisal to the concerned Reporting Officer and report and review APARs of their subordinates and submit

them to the concerned Reviewing Officer or the Principal CCIT, Delhi as the case may be, as per DOPT requirements at the earliest. A compliance certificate with regard to above shall be given in writing by the officer under transfer and the same shall be forwarded to Principal CCIT, Delhi.

The Officers under transfer shall strictly adhere to the following suggestion of CIT (CO) communicated vide letter No. F. No. CIT (CO)/DEL/516/2008-09/110 dated 15/04/2009:-

"The officer on transfer would continue to retain RSA token with him/her. However, the transferred officer would intimate his/her transfer detail (old/new designation & location) to FMS Helpdesk / ADIT (Network) in office of the CIT (CO) either through a phone call or through fax on 26105832 or through mail on devendra.kumar1@incometax.gov.in for de-linking RSA token from his/her old designation."
