They are also directed to complete the necessary actions related to merger/transfer of charge before relieving. RespectivePCsIT/HoDs shall ensure that all statutory requirements under Income-tax Act, 1961 are completed by these officers before relieving.

The Controlling Officers should ensure that the officer after being relieved submits his/her self appraisal to the concerned Reporting Officer and report and review APARs of their subordinates and submit them to the concerned Reviewing Officer or the Principal CCIT, Delhi as the case may be, as per DOPT requirements at the earliest. A compliance certificate with regard to above shall be given in writing by the officer under transfer and the same shall be forwarded to Principal CCIT, Delhi.
- 5. The Officers under transfer shall strictly adhere to the following suggestion of CIT (CO) communicated vide letter No. F. No. CIT (CO)/DEL/516/2008-09/110 dated 15/04/2009:-
