

- 5. All ITOs transferred vide this order shall be treated as deemed relieved w.e.f. 06.11.2020(F/N) and are directed to join their new place of posting by A/N of 06.11.2020. They are also directed to complete the necessary actions related to merger/transfer of charge before relieving. Respective PCsIT/HoDs shall ensure that all statutory requirements under Income-tax Act, 1961 are completed by these officers before relieving.
- 6. The Controlling Officers should ensure that the officer after being relieved submits his/her self appraisal to the concerned Reporting Officer and report and review APARs of their subordinates and submit them to the concerned Reviewing Officer or the Principal CCIT, Delhi as the case may be, as per DOPT requirements at the earliest.
