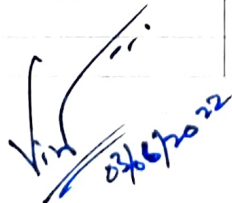

7. This order does not indicate *inter-se* seniority in the cadre of Income Tax Officers.

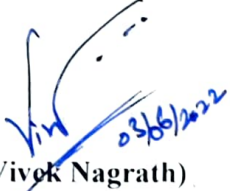
