- * The number of posts of the officials in the cadre of Inspector allocated to respective regions include the number of posts of Inspectors (380) withdrawn from the Assessment Unit(s) under the Addl./Joint Commissioner of Income Tax the Faceless Assessment Scheme of the respective regions vide this directorate's order No. 2 dated: 26.10.2020.
- 3. The above allocation is to ensure that the available sanctioned strength of the officials in the cadre of Income Tax Inspector, Sr TA/SG-I/OS, TA/Steno-II and MTS within the Pr. CCIT regions is equally distributed among the jurisdictional Pr. CsIT/CsIT

within the same region and there is no inter-region movement of the officials. This may result that in some Pr. CCIT regions the sanctioned allocation of the officials per Pr. CIT/CIT is more than that in other regions. In case the Pr.CCIT(CCA) wants to redistribute the posts of the officials among the Pr. CsIT/CsIT charges based on functional and other requirements, proposal in respect of the same may be sent to Directorate of the HRD to revise the sanctions accordingly.
